## 1 PURPOSE

The purpose of this report is to capture the outcomes of and summarise the feedback received on the Environmental Association for Universities and Colleges (EAUC) Scotland Branch Campus Sustainability Conference, held at Queen Margaret University (QMU) (Musselburgh) on 6 May 2008.

## 2 BACKGROUND

Since 2005 the EAUC has been providing support for practitioners in Scotland's Further and Higher Education Sector through the Campus Sustainability Programme (CaSPr). The Campus Sustainability Conference was held as part of CaSPr which has been funded by the Scottish Executive (Sustainable Action Grant) and the Scottish Further and Higher Education Funding Council (SFC). The conference signified the end of the first phase of CaSPr and the start of a second phase supported by the SFC.

## 3 THE CONFERENCE

### 3.1 Aims, intended audience and content

The main aims of the conference were:

1. To share the achievements of the Campus Sustainability Programme, demonstrating how the programme has initiated improvements in sustainability performance through its support for staff and students; and
2. To help Colleges and Universities identify how they should take forward their corporate responsibilities for sustainability.

The conference was designed primarily for senior managers, practitioners, lecturers, researchers and students working and studying within Scottish universities and colleges, and for those in public and not-for-profit agencies who are committed to helping the sector become more sustainable.

The event consisted of a morning plenary session with presentations from a range of speakers. The afternoon session gave delegates the opportunity to discuss in more detail some of the issues that had been raised in the morning. Over lunch and breaks, delegates were able to network and meet with exhibitors as well as take a tour of the new QMU campus. A copy of the final delegate pack which includes the conference programme is given in Appendix 1 and a final delegate list in Appendix 2.

### 3.2 Plenary

During the morning plenary a number of issues were raised which are given below:

1. What should be done to deal with the increased concerns expressed by the author of the Stern report who now admits that we need to invest 3% and not 1% of world GDP in climate change mitigation? A respondent said that top slicing the SFC budget to make these sums available was inappropriate; and instead climate change mitigation and should be embedded within the budget and activities of each institution.
2. Concern was expressed about the many current sustainability initiatives and the difficulty that practitioners faced in keeping on top of them all. It was proposed that the EAUC produce a guide to summarise the different initiatives.
3. Concern was also expressed that several institutions replying to the CaSPr State of the Campus Survey appeared (like many businesses) not to understand the legislation that applied to them. In response it was said that it was possible that people completing questionnaires did not have a full understanding of the legislative requirements however it did not necessarily mean that the institutions were not complying.

It was hoped that the strong support being given by partners like SEPA in the topic support networks would help institutions get a better understanding of the legislative requirements.

4. The view was expressed that some architects and design teams fail to take account of the implications of key legislation such as WEEE directive when allocating space etc in design and development of buildings.
5. The need to raise legislative issues with senior management was highlighted and reference was made to the help that could be given by the NetRegs SEPA website.
6. It was suggested that EAUC could take on a more active role in lobbying for change in the sector.
7. Also suggested was the need for CaSPr to engage with those institutions who were not represented at the conference. In response it was explained that a key aspect of the new CaSPr work would be to engage with institutions and staff who had engaged less than others or not at all.
8. It was stressed that EAUC wanted the new phase of CaSPr to be more than a three-year project and that there would be a dedicated post in Scotland which the EAUC regarded as a key milestone.
9. A key role for the Scotland Branch and new appointments will be to administer responses to consultations (through the "Topic Support Networks") for example to the new guidance on sustainable construction.
10. Reference was made to the good practice in construction in the Schools sector that could be readily transferred to FHE.
11. Timing and advertisement of events were seen as important for practitioners, particularly senior management.

#### 4 THE VENUE

The conference was held at QMU's new Musselburgh campus which opened in 2007. The building design maximises energy efficiency and the landscape design encourages biodiversity. The project has gained a BREEAM (Building Research Establishment Environmental Assessment Method) rating of "excellent" (the highest BREEAM score of any university in the UK). A number of leading environmental technologies are being employed at the site including biomass heating, thin-client computer technology and a sustainable urban drainage system.

## 6 CONFERENCE FEEDBACK

### 6.1 Attendance

70 individuals attended the conference out of 72 that were booked to attend. Table 1 illustrates the split between FE, HE and other organisations.

## 6.2 Usefulness

18% of those attending completed feedback forms, a low proportion and no feedback forms were returned from exhibitors. Of those 8 responding who provided information about the organisation for which they worked, 5 were from FE and 3 were from HE (the remainder did not respond to this question). The overall rating of the usefulness of the conference was a good 4.1 out of a total score of 5 where 1 was very poor and 5 very good. The previous conference held at the University of Edinburgh was rated as a 4.3 using the same scale. Table 3 and 4 shows the feedback from delegates for individual components of the conference.

## 6.3 Event management and structure

Overall the booking process and the information provided to delegates received good feedback, with the venue itself receiving the highest average score from delegates. The exhibition received the lowest score with the catering and structure of the conference and the tour getting ratings between 3.5 to 3.9 which is still over the satisfactory level of 3.

#### 6.4 Other comments

Delegates commented that the structure of the event was very good and that it provided excellent opportunities for networking and learning about what other practitioners are doing in the sector. Delegates commented on the great enthusiasm shown and the evidence of a continued growth in interest in environmental issues across the sector. Some delegates expressed frustration that HEIs were not doing more and emphasised the need for practitioners to persevere as although much was being achieved there was still much to be done. Many delegates were going to take further steps when they returned to their work; these included;

1. Applying for the VIBES award
2. Engaging with senior management about Scotland's Principals' Climate Change Commitment
3. Contacting organisations such as the Carbon Trust for assistance; and
4. Making further amendments to Scotland's Principals' Climate Change Commitment based on the feedback from delegates.

Delegates requested more specific examples (e.g. documents/guidance) drawn from the sector describing what is being done, how much it is costing and what type of returns are being achieved.

A number of other comments were made by delegates describing what would have helped improve the conference, these are summarised below:

1. More visual material and information available for delegates in the exhibition
2. More time for networking and socialising (opinion expressed by delegates taking lunchtime tour who had little time to network)
3. More detailed information on trains (i.e. provide a timetable) and give greater emphasis to the proximity of Musselburgh station to the campus
4. Better ventilation of the theatre which became very hot and stuffy)
5. More specific examples of the achievements of QMU
6. More detailed reference to legislative requirements rather than a review of NetRegs
7. The presentation on the SFC Sustainable Development Guidance for Estate Management should have stayed focussed on the topic
8. Less use of acronyms
9. Consider free attendance at conference
