



Universities and colleges in the UK have signed a unique agreement with the United Nations Environment Programme (UNEP) to bring British sustainability excellence to a global audience.

The Environmental Association for Universities and Colleges (EAUC), on behalf of its Members in the UK, has committed to a 3 year agreement with UNEP to link and support tertiary education institutions around the world.

As a follow-up to the Rio+20 Summit, UNEP recently convened the first session of the historic United Nations Environment Assembly (UNEA) in July 2014. UNEA presents a universal platform for leadership on global environmental policy, with participation of all 193 member states of the United Nations. As part of its strategic partnerships, UNEP has developed a Global Universities Partnership on Environment and Sustainability (GUPES), which seeks to foster closer linkages between UNEP's policy domain and universities across the globe.

This unprecedented agreement will put the prestigious Green Gown Awards on a truly global scale. The Green Gown Awards recognise exceptional sustainability initiatives being undertaken by universities and colleges. The Awards cover all aspects of educational institutions – from their teaching and research, leadership, buildings and food to how students can benefit the quality of life in the communities around them. The UK Green Gown Awards are now in their 10<sup>th</sup> year and their 5<sup>th</sup> in Australasia. With the inaugural French speaking Awards in July, the partnership with UNEP will expand the Green Gown Awards further across the globe with an emphasis on profiling and learning from the Southern Hemisphere. The ethos of the Green Gown Awards is to ensure the lessons and example of good practice are shared and this exciting partnership will put UK universities and colleges as leaders in sustainability as well as being able to continue their learning from global leaders.

The partnership will also bring together EAUC Members and the Global Universities Partnership on Environment and Sustainability (GUPES) network, around three key pillars of activities – education, training and networking. We will be delivering training and networking opportunities to radically increase the sharing of the Southern and Northern Hemispheres understanding on what sustainability means for an education institution.

As well as recognising good practice and learning from each other, we will also be working with UNEP to encourage universities and colleges, both in the UK and worldwide, to measure their sustainability performance. We are working with our partners on the [Platform for Sustainability Performance in Education](#), which was launched during an earlier session of UNEP's Governing Council in Nairobi, to improve how universities and colleges can measure, monitor and improve their sustainability performance.


UK universities and colleges, through the EAUC, are taking responsibility for their institutions and their students and ensuring that the UK is leading the way.
