

## Summary

EAUC-Scotland had a busy start to 2015 with the Spring TSNs being lined up, events organised for Waste Smart, facilitation and social media training, the HE CMP Review project getting underway, and meetings with a wide variety of members and strategic partners.

The team have also been working on various projects: RP is developing the careers project and engaging with the Association of Graduate Careers Advisory Service while also continuing the planning of the EAUC-S Conference for November; SL is managing the HE CMP review, funded through Scottish Funding Council and completed by June, as well as engaging with HEA-S and LfSS for a sustainability leadership programme; GG has continued to engage with members through events and meetings, and calls to Key Contacts gathering the UCCCfS Commitments and is the lead for the new Edinburgh regional group.

The Public Sector Reporting on Climate Change Duties consultation is open for comment and applies to all universities and colleges in Scotland. The consultation is due to close on the 29th May, with the amended reporting template to be implemented in early November 2015. A sector response will be collated after the forum, with all comments to be returned to scotland@eauc.org.uk by 18<sup>th</sup> May. A detailed communication on the consultation, outlining key documents, available support, and the consultation timeline, was sent to all Scottish educational contacts at the end of April.

The team attended and assisted with the EAUC-UK Conference held in Leeds at the end of March. There was a good turn out of Scottish representatives and a great number of productive workshops and networking opportunities, many of which are now boosting EAUC-Scotland events and projects looking forward.

It is hoped that EAUC Company and Educational members will be happy to provide job profiles and case studies for inclusion.  The Scottish and UK Offices are looking to work together on a workshop at the IEMA conference on graduate employment, although this is in the early stages of development.
