Legal spotlight



The rise in environmental taxes

As we start a new academic year, colleges and universities need to understand the impact of rises in environmental taxes introduced in July 2011.

The Finance Act 2011 replaces the Finance Act 2000 and makes a number of increases to taxes, including environmental taxes, which are likely to impact financially on colleges and universities.

The rates of the climate change levy paid on electricity, gas and other fuels will increase from April 2012. The levy is paid directly on fuel bills. Take a look at the table below for the new rates. As a result, universities and colleges will see energy bills rise above the predicted increases in domestic prices.

Fuel rate increases

Taxable commodity	Rate at which levy payable if supply is not a reduced-rate supply	Increase from rates in Finance Act 2000
Electricity	£0.00509 per kilowatt hour	18.4% increase
Gas	£0.00177 per kilowatt hour	18.0% increase
Any petroleum gas/other gaseous hydrocarbon supplied in a liquid state	£0.01137 per kilogram	18.4% increase
Any other taxable commodity	£0.01387 per kilogram	18.5% increase

The rate of landfill tax will also increase from £56 per tonne to £64 per tonne from April 2012, a 14.3% increase. If universities and colleges are still disposing of significant amounts of waste to landfill, considerable additional costs may be incurred.

In the last earth we told you about the Waste (England and Wales) Regulations 2011, the Waste (Scotland) Regulations 2011 and the Waste (Northern Ireland) Regulations 2011. Add these to the increase in landfill tax, and colleges and universities could make significant cost savings by reassessing their waste procedures to ensure they send as little as possible to landfill.

London Universities **Environment** Group (LUEG) has international appeal

The work of universities across London on reducing carbon will be featured in a documentary in South Korea later this year.

A journalist from KBS Radio, the South Korean equivalent of the BBC, visited the UK in July to find out how universities are stepping up their carbon reduction to ensure they meet the legally-binding targets set in the Climate Change Act 2008.

The journalist, Miss Park, interviewed Dr Victoria Hands, Head of Sustainability at London School of Economics and Chair of London Universities Environmental Group (LUEG) who outlined the work the sector is undertaking by drawing on examples from universities across the capital. This included a discussion about resource efficiency, the role of environmental champions and how students can contribute to potential solutions.

Miss Park explains:

"The documentary aims to discuss solutions to the energy crisis and climate change... Universities educate and develop the leaders of the future, and have a vital role to play."

Can Higher Education (HE) and Further Education (FE) work better together on sustainability?

Amidst a rapidly evolving sector and severe budget cuts, the ability for institutions to drive forward sustainability can be significantly affected. These are difficult times; financial resources have disappeared, some may lose focus amidst the need to increase income streams whilst for others, sustainability may quite simply drop off the agenda. I believe better collaboration and more innovative partnership working is the answer.



We are fortunate to have some common currencies - energy. carbon, waste, water and transport. Is there more that could be done to work closer together at a cross-institutional level? Can we strengthen our work, particularly locally, by sharing resources, staff, ideas, projects, costs, information and the benefits of success? The sector needs to transcend potential barriers and uncertainty to work together towards a vision that we all share - decreased impact on the planet and greater sustainability.

"Easier said than done" I hear you say. We all have to tackle organisational cultures, the natural pace of an institution and the inevitable local politics. In a rapidly changing environment, staff turnover and internal structural changes can be a real challenge, and it takes time to build up trust and relationships.

Perhaps there could be more visibility from local authorities, third sector organisations and sustainability bodies such as the EAUC when taking a greater lead to link and support institutions looking to collaborate.

Policy and consultation in Wales


At the Higher Education Funding Council for Wales (HEFCW), the focus will be on continued implementation of the Welsh Governments' higher education policy For our Future.

Input to their consultation on the future structure of higher education (HE) in Wales. This is available until 5 October at www.wales. gov.uk/consultations/education/ heinwales/?lang=en HEFCW will also be enhancing regional delivery of HE and continuing to embed sustainability within its policy development process.

HE reforms in England

As its top priority the **Higher Education Funding Council for** England (HEFCE) will be working with government, universities, colleges and other partners to implement the higher education reforms. It will also be:

Implementing the carbon reduction strategy for HE in England including allocating £10 million



through the Revolving Green Fund for projects that reduce greenhouse gas emissions www.hefce.ac.uk/ pubs/circlets/2011/cl16 11/). Deadline for applications: 17 October 2011.

Reviewing its sustainable development strategy in the light of the Higher Education White Paper 'Students at the Heart of the System' www.discuss.bis.gov.uk/hereform/

HE strategy in Northern Ireland

In Northern Ireland (NI), the focus will be on developing a HE strategy. A spokesperson from the Department for Employment and Learning in Northern Ireland (DELNI) said: "In the next year the Department will be developing and publishing a Higher Education strategy for NI which will include a strategic approach to maintaining NI's position as the

top UK country for widening HE participation." For more information visit www.delni.gov.uk.

Carbon in Scotland

The Scottish Funding Council (SFC) will make a statement on the contribution colleges, universities and the Funding Council make to the Scottish Government's carbon reduction targets. It plans to do this each year and will work closely with EAUC Scotland to estimate the carbon saved.

Mark Batho. Chief Executive of the Scottish Funding Council said: "We make a clear commitment to sustainable development in our corporate plan and we are now demonstrating, through our investments and policy developments, that we have an important role to play in creating a greener Scotland."
