The Higher and Further Education (HFE) sector in Scotland recognises the significant negative environmental, social and economic impacts of single-use plastic items and oxo-degradable products. In recent years, many institutions have committed to reducing and/or removing items listed above and others (including disposable cups and plastic bottled water) from campus operations with significant outcomes. For example, following a plastic awareness campaign and a student survey on the possibility of removing single use plastic items from the college's facilities, Dundee and Angus College officially stopped selling and supplying all disposable plastic items in 2018 including cutlery, cups and bottled water. These actions removed approximately 28 tonnes of plastic waste from the College's waste streams in just one year. Similar actions followed, including disposable coffee cup charges at the University of Stirling and University of Dundee. In addition, supported by the College Development Network, Scotland's College Principals agreed earlier this year collectively to remove plastic beverage containers from campus retail operations.

1(c) Do you support the introduction of a restriction on the manufacturing of the specified single-use plastic items, excluding those for which exemptions will be introduced? Please give reasons.

The sector recognises that waste management and its impacts are a global issue - first in terms of the embodied carbon within single-use plastic items contributing to climate change and, second, as demonstrated by the transport of waste and recycling to non-UK countries, a practice which has caused significant health and environmental issues for communities at or close to waste sites. The manufacturing of the specific single-use plastic items for a non-domestic market does not alleviate these wider issues, nor supports the drive in innovation needed to create sustainable behaviours and packaging.

In addition, we recommend a campaign alongside the rolling out of the proposed regulations that highlight the need of single use plastic items for some individuals. Additional information could also be displayed at catering and bar facilities.

EAUC-Scotland welcomes considerations for further market restrictions including plastic wet wipes and plastic tampon applicators. Alternatives to these items are available and align with wider sector awareness raising activities, particular with regards to sustainable sanitary products, for example Environmenstrual Week - https://www.eauc.org.uk/environmenstrual_week_highlights_sanitary_plast

Other items should also be considered. For example, Ireland is banning plastic condiment sachets, wet wipes and plastic hotel toiletries. France is banning plastic confetti, plastic toys being supplied with menus and plastic teabags. Canada will ban plastic grocery bags and six-pack rings, food take-out containers. We also think multipack wrapping, plastic cigarette filters and all single-use cups and food containers / plates / bowls in closed settings should be considered.

7 Do you believe the COVID-19 pandemic has resulted in changes to the market or wider economy that are not fully accounted for through this consultation? Please give reasons.

The COVID-19 pandemic has resulted in a huge global increase in plastic waste and pollution from items such as single-use disposable masks, gloves and wipes and hand sanitiser bottles. The Scottish HFE sector feels this overrides many of the hard-won behaviour change and policy successes within institutions relating to single use resource items. Since the onset of the Covid pandemic, concern over hygiene has meant that reusable containers and cups have been turned away. However, research shows that reusables are as safe and over 100 scientists from 18 countries have signed a letter outlining the evidence to show that 'reusable systems can be used safely by employing basic hygiene'.

Additionally, the crisis has also had an effect on relevant policy in Scotland. The Circular Economy Bill, which was due to be introduced in spring 2020, has been delayed. This is more important than ever as we recover from this pandemic to drive a circular recovery, making Scotland more resilient to future global crises and creating circular business opportunities.

Although single-use plastic is a particular problem due to the nature of plastic in the environment, single-use in general is also problematic as it is wasteful of natural resources. Re-useable alternatives are preferable to single-use items made from another material. Where there are re-useable alternatives, a ban on single-use (regardless of material) might be appropriate.
