EAUC Scotland's Mission is to inspire, empower and support leadership and collaborative action for sustainability across the Scottish further and higher education (FHE) sector. Our programme

Accelerating action and leadership in Scotland's universities and colleges in order to respond to the Climate Emergency, running from April 2020 to March 2023, continues to support this mission.

Ambitious and far-reaching in scope, this programme builds on the success of previous EAUC Scotland programmes and sector progress to date. It also recognises the need for a step-change in leadership and action across institutions in order to fully contribute to Scotland's national ambitions on the climate emergency, as well as delivering the social, economic and educational benefits to individual institutions and their campus and wider communities.

Our work aids our members, sustainability experts and advocates to share and advance knowledge. EAUC Scotland directly engaged with 8 partner network steering groups or working groups.

There are no year-end financial concerns for the programme. Previous savings made through reduced events and business travel expenditure due to COVID-19 were reinvested in increasing staff resource for Year 2 & 3 of the programme to support the sector further.

Reflecting over the past 3 years as this programme comes to a close, it has been a period of significant disruption and change due to the impacts of COVID-19. But it has also been a period of growing sustainability leadership within Scotland's colleges and universities: 1,800+ participants have joined 97 EAUC Scotland events, engaging 93% of Scotland's colleges and universities; 25 more institutions have committed to Race to Zero and a further 9 have signed the SDG Accord; Scotland's Colleges all backed their Statement of Commitment on the Climate Emergency and the public sector has new guidance from Scotlish Government on leadership within the global climate emergency. There are many more sector highlights.

We still have a long way to go in ensuring an environmentally and socially sustainable future for all as the latest IPCC report shows, but from all the team at EAUC Scotland, thank you for being part of that journey with us and championing a better future.
